- Monitoring against the five Cyber Essentials Technical Controls
- Identification of key cloud services in use by all devices
- **Device Behavioural monitoring**

For enhanced Security:

- DNS Firewall that blocks "bad" sites
- Internal Vulnerability scanning
- **External Vulnerability scanning**
- VPN for mobile workers
